RESOLUTION NO. 18 (SERIES 2026)

A RESOLUTION CREATING AND MAINTAINING A PENALTY SCHEDULE FOR VIOLATIONS OF TITLE 10 OF THE GYPSUM MUNICIPAL CODE

A. The Town of Gypsum, Colorado (“Town”) is a home rule municipality organized and existing under Article XX of the Colorado Constitution and the Town’s Home Rule Charter effective October 21, 1982.

B. Title 10 of the Gypsum Municipal Code (“Title 10”) addresses traffic code offenses enforceable within the Town and provides for penalties and enforcement; and

C. Title 10 authorizes the Town Council (“Council”) to adopt by resolution a penalty schedule for violations of Title 10.

D. The Council finds and determines that establishing and maintaining a clear and consistent penalty schedule for violations of Title 10 will promote the public health, safety, and welfare, deter violations, and provide fair notice to the public.

E. The Council has reviewed the proposed penalty schedule attached hereto as Exhibit A and finds it to be reasonable and in the best interest of the community.

F. Adoption of the penalty schedule by resolution is consistent with the Town’s Charter and the Gypsum Municipal Code.

G. The Council desires to adopt the attached penalty schedule and to clarify that the schedule supplements, and does not limit, any other enforcement remedies available at law or in equity.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GYPSUM, STATE OF COLORADO THAT:

1. Title 10 Penalty Schedule. The Council hereby adopts the Title 10 Penalty Schedule set forth in Exhibit A, which is incorporated herein by reference.

2. Repeal and Ratification. All resolutions of the Council inconsistent with this Resolution are hereby repealed to the extent of such inconsistency and all actions of the officers, agents and employees of the Town which are in furtherance of or in conformance with the purposes and intent of this Resolution are hereby in all respects ratified, approved and confirmed.


3. Severability. If any part, section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining provisions.

4. Effective Date. This Resolution shall take effect and be enforced immediately upon its approval by the Council.

This Resolution was introduced, read, and adopted upon a motion duly made, seconded, and passed this 23rd day of June 2026, by a vote of 7 in favor and 0 against.
